

Even with the lockdowns and restrictions our Young People throughout the District took part in national sleepovers, virtual camps and virtual craft days organised by the County.

Our Six Dales - With a Difference was a fabulous event and gave people the opportunity to get out and get active. We also gave Young People the chance to get their voices heard and help shape the District.

Although as a District we have a reduction in overall numbers, we did see a small increase in the number of Scouts, but we had an 8% growth in the number of Explorers compared to last year!



Appointments Committee

Appointments Advisory Committee panels met 9 times between 1st of February 2020 and 31st of January 2021, seeing 35 applicants for Leadership roles, 29 new and 6 Changes of Roles.

(There were 68 and 66 in the periods February 2018 to January 2019 and February 2019 to January 2020 respectively).

The meetings held in February and March 2020 were face-to-face and the remaining 7 meetings were held virtually using Zoom.

We now have an established practice of holding an Appointments Team meeting in or around November each year, with the District Commissioners and Local Training Manager present, to review our procedures and to take in to account any new guidance from HQ. Where necessary, we then present updates to our governing body, the District Executive Committee (or Board of Trustees) for its approval.

Fred Overfield let us know on 2nd of March 2021 of his wish to retire from his role on the committee. North Leeds Scouts are most appreciative of his wise contributions to the appointments process in the District during his 18 years of service. His ability to draw on long experience in Section Leader, Group Scout Leader and Commissioner roles has been invaluable to us.

The Appointments team comprises Amy Connor, Roger Cook, Ted Fairfax, Helen Lee, John Lillywhite, Keith Warner, Alex Pearson and Pam Warburton.

Whilst Roger currently continues as Secretary, his wish is to retire from the role by the end of September this year. Having started in April 2011 he has served conscientiously and loyally for 10 years. His successor will find his record keeping and processes a great help in taking on the role.

In recognition of this and other service including that as a Section Leader Cubs Scouts for more than 20 years and a Group Secretary for 10 years, the District Awards Panel was very pleased to be able to recommend Roger for the Award for Merit which was received in August last year.

It remains an objective to recruit more people to the committee in order to widen the diversity of its personnel in line with that of North Leeds Scout District as a whole. I would be pleased to hear from anyone interested in joining the team.

District Chair

Achievements and performance

During 2021 the Trustees focussed on two key priorities: supporting the recovery of Scouting following the Covid-19 pandemic; and a strategic review of North Leeds Scouts' governance, policies, and practices.

Supported by our Groups, the District has been able to provide a range of activities to enable and encourage Sections to return to face-to-face Scouting. This included laser tag equipment at Wike Campsite and the availability of a large marquee for usage to provide shelter for Groups who may not have access to outdoor areas or shelter, kindly provided by 16th Alwoodley. Without this generous support, hundreds of Young People may not have had the opportunity to return to some form of normality. As restrictions ease the District will look to provide access to more of the facilities at Wike, including the hut and associated spaces.

At this point I would like to recognise and thank the dedicated team of volunteers who have continued to maintain and enhance areas of the site, ever improving in anticipation of Young People returning to Wike once again.

The annual census in January illustrated the full impact of the pandemic, with our youth membership falling by 175 members to 1,292 (2020: 1,467). This 12% reduction in membership is less severe than feared, with some Sections growing in size over the course of the year. This of course is down to the incredible effort from our adult volunteers who have adapted programme and delivery methods to allow our members to thrive during this pandemic.

In the background, the Trustees have been working to systematically review the way we operate, ensuring our governance is fit for purpose. This has involved a substantial piece of work in reviewing the composition of the Executive committee and sub-committees, our policies, and operating procedures. An immediate outcome of this work is the newly formed Wike Steering Group, designed to build on the fantastic developments at Wike over the last few years, and ensure a focus on a longer-term strategic plan for the site.

Plans for future periods

Whilst things may seem gloomy at the time of the year end, we move forward with a cautious optimism for the future that we will all come through this together, standing tall and ready to get back to providing life-changing opportunities and adventures to hundreds of Young People on a daily basis.

With restrictions easing and the District settling, we are actively looking at how we can continue the work undertaken before to grow and develop Scouting across North Leeds and move forward to support our Groups and Young People through the post-pandemic recovery.

Trustees' Report

Purpose and activities

The primary purpose of North Leeds District Scout Council ("the Council") is to promote the development of Young People through achieving their full physical, intellectual, social and spiritual potentials, as individuals, as responsible citizens and as members of their local, national and international communities. This is achieved through the support of a quality programme of activities, events and expeditions.

These benefits are available to all Young People and are therefore considered to be a public benefit under Section 4 of the Charities Act 2011.

Structure, Governance and Management

The Council is established under the governing instruments of The Scout Association, which are common to all Scout organisations. These consist of the Royal Charter, which in turn gives authority to the Bye Laws and the Policy, Organisation and Rules of The Scout Association.

The Council, which is registered as an educational charity, is managed by the Charity Trustees, who together form the District Executive Committee ("The Executive Committee").

In fulfilling its responsibilities, the Executive Committee is supported by the following sub-Groups, which report to it at each meeting:

- •The District Senior Leadership Team
- •The District Appointments Advisory Committee
- •The Wike Steering Committee
- •The Six Dales Walk Committee

The District Commissioner and District Chair are ex-officio members of all sub-committees.

The Trustees are responsible for complying with the legislation applicable to charities. This includes registration, keeping proper accounts and making returns to the Charity Commission as appropriate. They must act in the best interests of the District's members to:

- •Comply with the Policy, Organisation and Rules of The Scout Association.
- Protect and maintain any property and equipment owned by and/or used by the District.
- Manage the District finances.
- •Provide insurance for people, property and equipment.
- •Provide sufficient resources for the District to operate. This includes, but is not limited to, supporting recruitment, other adult support, and fundraising activities.
- •Promote and support the development of Scouting in the local area.
- •Manage and implement the safety policy locally.
- •Ensure that a positive image of Scouting exists in the local community.
- •Appoint and manage the operation of any sub-committees, including appointing a Chair to lead

Risk and Internal Control

The District has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss. These include appropriate approvals for payments and insurance policies to ensure that insurable risks are covered.

Grants Policy

The Council aims to provide appropriate resources to enable all Young People in North Leeds to undertake Scouting activities, expeditions, and training irrespective of their background, financial ability or special needs. The Trustees have created a 'Make it Happen' Fund in the interests of supporting this goal.

Activities and Volunteers

A summary of the main activities of the District is included in the accompanying District Commissioner's reports. The Trustees are most grateful of the considerable amount of voluntary help that is given to all aspects of Scouting throughout North Leeds.

Appointment of Trustees

The Trustees of North Leeds District Scout Council are members of the Executive Committee. There are four Groups of trustees as follows:

- •Ex-officio
- •Elected (by the Council)
- Nominated (by the District Commissioner)
- Co-opted (by the Trustees)

The ex-officio trustees are the:

- District Chair
- District Treasurer
- District Secretary
- District Commissioner
- District Youth CommissionerDistrict Explorer Scout Commissioner
- •District Scout Network Commissioner

There may be a maximum of four elected trustees, four nominated trustees, and four co-opted trustees.

Trustee induction and training

New Trustees are trained in their responsibilities and duties by the longer serving Trustees. Trustees must also complete mandatory training as specified within Policy, Organisation and Rules.

Treasurer's Report

The District Executive Committee has approved the District's Annual Accounts for the year to 31 January 2021. The accounts have also been examined and approved by our Independent Examiner Nick Russell, who has now completed his fourth year in this role and as such has reached the end of his term of office and we thank him for his excellent service.

As with the rest of the Country the District's activities for this year have been changed beyond all recognition due to the Covid-19 pandemic. This has had an effect on the District's finances in many ways.

A number of grants have either been applied for or been automatically allocated to Scout Groups within the District either as a result of property ownership and revenue from those properties being reduced or as assistance to Groups that were severely affected by Covid-19 restrictions.

The overall impact on the District has been managed and whilst income has been reduced the District's reserve emergency funds have been used exactly for the purpose that they were intended.

Due to a fantastic effort from all Sections and Explorer Units, we were able to complete the Annual Accounts at the end of January to put us in a position where the District could provide upto-date examined accounts to support additional grant applications. This was a tremendous effort in such a short space of time.

The mandates for the District's day-to-day current account with HSBC and the newly opened bank accounts with Virgin Money which are for the use of newly formed Groups and the Make it Happen fund have been amended to reflect the change in the District's Executive Officers.

On a day-to-day level the District's finances are in a healthy state which meant that should the need have arisen, the District would have been able to support Groups that were struggling due

to the changes Covid-19 brought about. Thankfully, this was on the whole not required.

Another impact of Covid-19 was that the District took the decision not to implement the planned increase in Membership Fees from £3.00 per young person to £6.00. This decision will be revisited once the full impact of the pandemic is understood.

Once again the collection and subsequent payment of membership subscriptions to the County was a relatively straight forward process mainly due to individual Groups making their payments within the required timeframe and the simplification of the calculation and billing of Young Leaders. Again, many thanks to all the Groups this made my job a lot easier.

In 2020 we paid to the County and Headquarters £53,664.00 in membership fees.

2020 also saw the completion and full settlement of all invoices for the Wike Kitchen and Toilet projects this process has relied heavily on a number of individuals managing the payment of invoices from suppliers, again my thanks to them for their efforts.

Looking forward I think this coming year 2021/2022 will settle back down into a more usual routine. The key objectives for the year are to agree on the new Membership Fee structure, complete a longer term budgetary strategy and consider the current banking arrangements in light of the closure of the HSBC branch in Chapel Allerton.
